

EPA Accredited Renovation, Repair, and Painting Training Course (RRP) being held in Vancouver, WA!

What is the RRP Rule?

In 2008 the EPA established the Renovation, Repair and Painting Rule (RRP) Rule 40 CFR Part 745, Subpart E. The Rule requires Landlords, Contractors, Sub-Contractors, On-Site Maintenance and Management Employees to comply with lead safe work practices in target housing or child-occupied facilities. **THIS IS A FEDERAL LAW AND AS OF 4/20/2010 IS NOW IN EFFECT!**

Who does it affect?

Up to 75% of owner operator LANDLORDS. Up to 50% of all registered CONTRACTORS. Up to 75% of PROPERTY MANAGEMENT companies. Up to 20% of real estate professionals, and up to 80% of Housing Authorities.

What property types are affected?

Residential Housing and Child-Occupied Facilities.

Target Housing is ANY housing built before January 1, 1978. Child-Occupied Facilities include daycares, pre-elementary schools, and kindergarten classrooms.

What types of activities are affected?

Prepping* for paint, either interior or exterior. Drywall repair*. Removal of the following building components; Floor covering, base, molding, doors, door trim or frames, stairs railings, cabinets, vanities, counter tops, windows among other things. Plumbing*. Electrical*. (*signify square footage requirements of paint disturbance 6 sq ft per room interior, 20 sq ft total exterior)

What are the focus areas of compliance?

Pre-renovation education and work safe practices. Renovate Right is a mandatory book given to tenants and home owners before work proceeds. There is a form in the back that must be filled out and kept by a certified firm for three years.

What are the penalties for non-compliance?

Up to \$37,500.00 per violation for failure to educate and use work safe practices.
